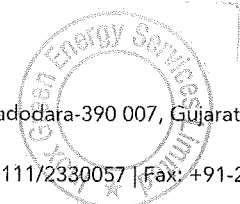
Gist of proceedings of the 11th Annual General Meeting (AGM)

- The Chairman briefed the Members, inter-alia, on the operational and financial performance of the Company during the Financial Year 2022-23.

- Special Business

4. Ratification of payment of remuneration payable to M/s. Jain Sharma and Associates (Firm Registration No. 000270), Cost Auditors of the Company for the Financial Year ending on 31st March, 2024 (Ordinary Resolution)
 5. Approval of Material Related Party Transactions (Ordinary Resolution)
