Pursuant to Regulation 51 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we wish to inform that the Company has sold its entire investment held in its wholly owned subsidiaries namely Wind One Renegy Limited ("WORL"), Wind Three Renegy Limited ("WTRL") and Wind Five Renegy Limited ("WFRL") representing 100% of paid up capital of WORL, WTRL and WFRL to Adani Green Energy Limited, a part of Adani Group.

WORL, WTRL and WFRL had commissioned 50 MW each in 2019, out of the total 250 MW which the Company had successfully won under the Tranche 1 of Solar Energy Corporation of India Limited's (SECI -1) bids for wind power projects at Dayapar, Gujarat connected on the central grid at affixed tariff of Rs. 3.46/ unit for 25 years for sale to PTC India.

Consequent upon the said sale of shares, WORL, WTRL and WFRL have ceased to be subsidiaries of the Company w.e.f. 7<sup>th</sup> October, 2022.
