**Re: Response to the letter dated August 18, 2022 ("Fresh Rejoinder") filed by LNJ Power Ventures Limited ("Complainant") to the reply dated August 15, 2022 filed by Inox Green Energy Services Limited ("Company") ("Reply to Rejoinder") to the rejoinder dated August 11, 2022 filed by the Complainant ("Rejoinder") which was filed against the reply dated August 8, 2022 filed by the Company ("Reply") to the letter dated July 30, 2022 and SCORES complaint dated August 5, 2022 filed by the Complainant ("Complaint"), in relation to the draft red herring prospectus dated June 17, 2022 ("DRHP") filed by the Company for its proposed initial public offering of equity shares ("Offer")**

We are in receipt of your Fresh Rejoinder.

In relation thereto and without prejudice to our rights, please find below our response:

As specified in our Reply and our Reply to Rejoinder, all the disclosures included in the DRHP are in compliance with the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended ("**SEBI ICDR Regulations**") and the materiality policy adopted by the board of directors of our Company ("**Board**") for disclosures to be made in the DRHP, red herring prospectus, prospectus and any other documents in relation to the Offer (collectively, the "**Offer Documents**") (such policy, "**Materiality Policy**"). We have appropriately responded to the Complaint and the Rejoinder by our Reply and our Reply to Rejoinder, respectively, and we have nothing further to add as a response to the Fresh Rejoinder.

We further reiterate that your allegations about material suppression of facts, falsehood, false and incorrect statements and incomplete disclosure of outstanding litigations by our Company holds no merit. Please note that none of the contents of the Fresh Rejoinder, may deemed to be admitted merely on the reason that our Company is not specifically dealing with any averment, allegation or submission.

The Complainant is not a party to the relevant statutory matter as specified in our Reply to Rejoinder. The Complaint, Rejoinder and the Fresh Rejoinder (together, the "**Correspondences**") have been made with a malicious intent and to delay the proposed Offer. Further, please note that the Securities and Exchange Board of India is not the appropriate authority to adjudicate on alleged breach of contract and/or the alleged commercial losses incurred or to be incurred by the Complainant.

Trust this clarifies.

All capitalised terms not specifically defined herein shall carry the same meaning as ascribed to them in the DRHP.

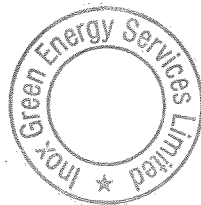
