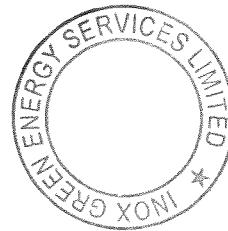

We are in receipt of your Complaint. In relation thereto and without prejudice to our rights, please find below our response:

Please note that the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended ("**SEBI ICDR Regulations**") do not require our Promoter to settle its pending dues prior to the initial public offer of our Company. Further, per the provisions of the SEBI ICDR Regulations, our Company is not required to disclose such pending dues of our Promoter in the DRHP, red herring prospectus, prospectus or any other documents in connection with the Offer.

Notwithstanding the above, based on the acknowledgement issued by the Complainant, we understand that the Complainant has received the full and final settlement amount from our Promoter on October 17, 2022. Further, the Complainant has confirmed that he has no claim or complaint against our Promoter except for the receipt of form 16 for the financial year 2021-22 and the payment of provident fund. Basis the confirmation received from our Promoter, we understand that form 16 for the financial year 2021-22 and the payment of provident fund will be processed in due course.

Please note that none of the contents of the Complaint, may be deemed to be admitted merely on the reason that our Company is not specifically dealing with any averment, allegation or submission.
